

Course Objectives

This course is not intended to prepare students to be attorneys. It is to give business managers a better sense of how to steer clear of legal jeopardy and when to call a lawyer. We will study the American legal system, with an emphasis on common law rules and federal statutes which affect the business environment, and briefly compare systems in China, Europe, and other continents. Cyberlaw and the effect of social media and electronic devices and technology are also explored. If feasible, students will take a field trip to a courthouse and observe the proceedings. Students will come to see the law and legal systems in a way different than they see them now.

Course goals include:

1. Achieving understanding of the nature, function, and practical operations of the legal system as well as of the societal forces that shape the law.
2. Practicing the skill of legal reasoning.
3. Enhancing analytical and critical thinking skills.
4. Improving communication skills and the ability to persuade others.
5. Increasing understanding of legal rules that impact business by restricting or facilitating business operations, and the important legal issues facing international business today.
6. Seeing the interrelationship of ethics, legality, and business decisions.
